Getting Repairs Done

Steps to Follow:

- Write a letter to your landlord and ask for the problem to be fixed within a reasonable amount of time. A sample letter is on the back of this brochure. Keep a copy for your records.
- 2. Keep track of the problem by taking pictures, videos, and/or using witnesses.
- 3. If your landlord does not fix the problem after a reasonable amount of time, call the Property Standards Inspector in your municipality and ask for an inspection.
- 4. If your landlord still does not fix the problem, apply to the Landlord & Tenant Board to get your landlord to do the work.

Property Standards By-Laws:

Each municipality has property standard by-laws. These by-laws set out minimum standards for buildings and land so that they are safe.

You can ask for an inspection for problems like:

- ♦ Water
- ♦ Building Repairs
- ♦ Sewage problems
- ♦ No Heat/Hydro

If your municipality does <u>not</u> have a property standards by-law, call the Rental Housing Enforcement Unit (RHEU) of the Ministry of Municipal Affairs and Housing at **1-888-772-9277** or visit their website at <u>www.mah.gov.on.ca/ieu</u>. Ask them for an inspection.
